The KMITL Business School, King Mongkut's Institute of Technology Ladkrabang, is calling for applicants to its 2023 International Undergraduate Program. This round of admission is open for Thai undergraduates internationally or locally. Candidate selection in this Portfolio Presentation is based on the following criteria

1. Programs of study and Number of admitted students

- Bachelor of Business Administration in Global Entrepreneurship (International Program).

All teaching materials and learning activities in the program are conducted in English.

The number of students to be admitted this round is 20 students.

2. Applicant qualifications

Applicants for this Portfolio Presentation are required to meet the following requirements:

Graduated from or studying in the final year of school, grade 12 (US system), year 13 (British system), or Matthayom 6 (Thai system), or equivalent at an accredited college or educational institution in Thailand or abroad.

The applicant must satisfy one of the following requirements:

2.1 The applicant has obtained or is expected to obtain, before the start of the Academic Year 2023, a qualification equivalent to a high school diploma. The applicant's GPAX will not be considered the main criterion for admission.

Other qualifications that are preferable:

2.2 The interview committee will consider applicants who provide evidence of English proficiency and/or mathematics test scores as a plus.

If the prospective student is a non-native English speaker or does not hold an international high school diploma (English Program), he/she should obtain a test result from one of the following tests: Test of English as a Foreign Language (TOEFL ITP), International English Language Testing System (IELTS) or other standardized English Language Proficiency Tests such as CU-TEP, TU-GET, and KMIL-TEP. Or

2.3 Personal Statement: Students should provide their statement in English, answering the question: "Why do you want to join BBA in Global Entrepreneurship?" (not more than 1-2 pages, please submit with the application).

2.4 Having a strong ambition to be an entrepreneur by reflecting it in the personal statement or having a family background in entrepreneurship by showing evidence that his/her family possesses a business. Or

2.5 Having experience as an exchange student in a country where English is an official language, having experience in a multicultural environment such as a cultural exchange program, an English competition, a family business with international trades, experience from living overseas, public speaking in English or any other remarkable performance.

2.6 The applicant must complete the GED program. The applicant can submit a GED (with at least 145 on each test subject) as equivalent to having studied at high school for the interview committee's consideration.

** Please note that the applicant must satisfy one of the requirements above and be presented to the committee at the interview. The interview committee will consider whether the applicant is qualified to study. **

Essential qualifications

1. Applicants must be under the Domestic form of Government with the King as the Head of the State. Applicants must understand and respect the Royal Highness which the King is the Head of the State as a form of Thai Government.

2. Applicants shall be physically and mentally healthy.

3. Applicants must demonstrate good behavior and good attitudes toward their studies and strictly conform to the Institute's rules and regulations.

4. Applicants should not have been expelled from any other institute because of improper behavior.

5. Applicants must be authorized to stay in Thailand legally.

6. Applicants should not have been punished for corruption in any exam.

7. Applicants should not have been dismissed from any institute because of liabilities.

5. Admission

The admission acceptance is based on:

- The interview by the committee
- Applicant qualifications
- Other qualifications described on the application form
- English proficiency
- Interest in pursuing the Business Administration in Global Entrepreneurship Degree (International Program)
- Proper personality for Business Administration in Global Entrepreneurship (International Program)

*** The judgment of the interview committee is final. ***

6. Clearing House eligibility confirmation

Qualified candidates must confirm their Clearing House eligibility through the system of the Council of University Presidents of Thailand (CUPT) to express their intention to study as students of King Mongkut's Institute of Technology Ladkrabang within 7 - 8 February 2023, if it is not performed within the specified date and time, it will be considered a waiver.

7. Announcement of the admission

KMITL Business School, King Mongkut's Institute of Technology Ladkrabang, holds the right to select eligible and qualified applicants. The announcement of accepted students will be posted on the Office of the Registrar's Website: <https://new.reg.kmitl.ac.th/admission/> on 14 February 2023.

8. Confirmation of the student's status and tuition payment

Applicants who have been accepted for enrollment (Clearing House) at King Mongkut's Institute of Technology Ladkrabang, shall confirm their admission via <https://new.reg.kmitl.ac.th/admission/> and pay their confirmation payment within 17 - 23 February 2023. Not confirming and/or any avoidance of any process may result in disqualification. Any payments, application fees, and/or confirmation payments made by the applicants are non-refundable.

9. Reporting of eligible candidates and paying to confirm the right to study in the institute

Those who have passed the selection and have been announced as eligible to study at King Mongkut's Institute of Technology Ladkrabang must report their eligibility to study via <https://new.reg.kmitl.ac.th/admission/> and make a payment of confirmation. According to the announcement of the institute regarding payment of confirmation of eligibility to study in King Mongkut's Institute of Technology Ladkrabang on March 2, 2012, failure to do so by the specified date and time will be considered a waiver.

Eligible applicants who have confirmed their admission by paying and reporting online but have decided not to study in the institute, will not receive a refund from the institute in any case.

Eligible applicants who have paid and confirmed their eligibility to study, when becoming a student of the institute, do not have to pay the tuition fee for the first semester. It shall be deemed that the aforesaid confirmation fee includes the tuition for that semester.

10. Disqualification

10.1) Accepted applicants who have not yet confirmed enrollment (Clearing House) within the specified time will be considered disqualified.

10.2) Accepted applicants who do not confirm the enrollment (online) and do not make the payment within the specified time will be considered disqualified.

10.3) Accepted applicants who have not obtained a high school diploma before the start of the Academic Year 2023 will be considered disqualified.

11. Tuition

Qualified applicants who have been accepted as students of the KMITL Business School must make a payment of 50,000 Baht per semester for tuition. Please note that the application payment is non-refunda

In the case that the applicant has submitted any forged documents or found non-compliant to the qualification requirements, the committee will immediately disqualify the applicant. The committee's judgment will be considered and deemed final.
