The School of Food Industry, King Mongkut's Institute of Technology Ladkrabang, invites qualified applicants to apply for admission to the **Bachelor of Science Program in Culinary Science and Foodservice Management (International Program)** in Academic Year 2023 (Starting in JULY 2023).

This program is a collaboration between the School of Food Industry, King Mongkut's Institute of Technology Ladkrabang (KMITL), Thailand, and Business and Hotel Management School (B.H.M.S.), Switzerland. The program consists of 4 years of study with 3 years at KMITL in Thailand and 1 year at B.H.M.S. in Switzerland.

The Applicant's requirements and application procedure are presented as below.

## 1. Program

1.1 Bachelor of Science Program in Culinary Science and Foodservice Management (International Program) B.Sc. (Culinary Science and Foodservice Management)

1.2 Triple degrees given to the Graduates

1.2.1 KMITL, Thailand:

Bachelor of Science (Culinary Science and Foodservice Management)

1.2.2 B.H.M.S, Switzerland:

Bachelor Degree in Culinary Arts (B.A. Degree Culinary Arts)

1.2.3 Robert Gordon University, United Kingdom:

Bachelor Degree in Culinary Arts (B.A. Degree Culinary Arts)

1.3 Acceptable candidates: 10 students/ Academic year

## **2. Applicant qualifications**

### 2.1 General qualifications

2.1.1 The applicant should have sound physical and mental health fit for studying and working in the field of culinary art and foodservice management.

2.1.2 The applicant should not have been expelled from any other institute due to any kind of improper manners or offenses.

2.1.3 The non-Thai applicant must possess their own passport. The expiry date of the passport should be no less than 6 months from the last day of the application period.

2.1.4 The applicant must demonstrate good behavior and good attitudes toward their studies and conform to the Institute's rules and regulations.

### 2.2 Specific qualifications

2.2.1 Academic qualifications: The applicant must have completed (or be expected to complete before the day of the enrollment) one of the following qualifications:

a) Mathayom 6 or equivalent in a regular Thai program in the Science-Math or Art-Math study track, as approved by the Ministry of Education of Thailand

b) Grade 12 in the US education system

c) Year 13 in the UK education system

d) A qualification equivalent to a high school diploma as published by the Council of University Presidents of Thailand available for download

2.2.2 Standardized academic test (one of the following):

a) TGAT (General Aptitude Test) with a score of 50 or higher and A-LEVEL Math2 with a score of 50 or higher

b) SAT with a score of 1000 or higher

c) Any other national or international academic qualification equivalent to the tests in 2.2.2 (a) and (b).

Only a valid score report (i.e. not already expired) on the day of the interview will be taken into consideration.

2.2.3 English language proficiency test (one of the following):

- a) TOEFL (ITP or paper-based test) not less than 500
- b) TOEFL (Internet-based Test) not less than 65
- c) IELTS (Academic Module) not less than 5.5
- d) Cambridge English Exams (FCE/CAE/CPE) not less than 160
- e) CU-TEP not less than 65
- f) A-LEVEL Eng with a score of 60 or higher

Only a valid score report (i.e. not already expired) on the day of the interview will be taken into consideration. A mandatory IELTS score of 6.0 or higher is a pre-requisite for the 1-year study at B.H.M.S, Switzerland, for all accepted students.

In the case that any applicant does not meet the requirements in 2.2.3, the applicant can still apply, depending on the discretion of the program.

#### 4. Application documents

4.1 A completed application form with a color photo (25 mmx 30 mm, clear face, without hat and sunglasses, taken less than 6 months, with the applicant's signature at the back)

4.2 For a Thai applicants, a copy of the Thai national ID card. For a non-Thai applicants, a copy of the passport (photo page, expiry date no less than 6 months from the last day of the application period)

4.3 A copy of an academic certificate or document confirming that the applicant satisfies the requirements in section 2.2.1.

4.4 A copy of the standard academic test as specified in section 2.2.2

4.5 A copy of the English proficiency test as specified in section 2.2.3

4.6 A copy of the certificate of personal name change (if any)

4.7 A personal statement describing the applicant's motivation for studying in this program as well as their expectation for the program. The statement should be typewritten in English, not exceeding 1000 words in length, on an A4 sheet using the Arial or Times New Roman font and the font size of 12.

4.8 A portfolio presenting the applicant's abilities, achievements, and activities that are related to this program or showing the applicant's intention to study in this program.

Please note that the applicant is responsible for checking and certifying the authenticity of all the submitted documents before submission. The applicant is required to write "Certified true copy of an original document" and sign their name on every photocopy page of their application documents. The applicant who submits fake, incorrect, or incomplete application documents will not be considered and will be disqualified. The judgment made by the admission committee of the School of Food Industry, KMITL, shall be deemed final.

## **5. Application submission and application fee**

5.1 Complete and submit an online application at <http://www.new.reg.kmitl.ac.th/admission/>

5.2 After submitting the online application, print out the application fee payment form and pay the application fee by 2 methods as followed:

5.2.1 Scan barcode presented in the application fee payment, and pay application fee (1000 Baht) via bank applications

5.2.2 Pay application fee (1000 Baht) at any branch of Kasikorn Bank (1000 Baht, not including any bank fee)

For the non-Thai applicant who resides abroad and has difficulties in paying the application fee through bank applications or Kasikorn Bank in Thailand can pay their application fee (1000 Baht) on the day of the enrollment.

Please follow the application schedule specified in section 3. The date on the postmark will be considered as the application submission date.

5.4 The application shall be considered completed after a confirmed payment of the application fee within the application deadline. Please note that the application fee is non-refundable.

## **6. Applicant selection**

The selection of the accepted applicants is based on the applicant qualifications specified in section 2, the personal statement, the portfolio, the English language proficiency, and the determination and suitability for studying in the program, as well as the result of the interview by the committee. The judgment made by the admission committee is final.

## **7. Disqualification**

7.1 For Thai applicants, the accepted applicants who do not accept the offer on the TCAS Clearing House system within the specified time will be considered disqualified.

7.2 The accepted applicants who do not confirm the enrollment (online) or do not make a complete payment of the tuition fee within the specified time will be considered disqualified.

7.3 The accepted applicants who is unable to prove the completion or possession of the qualifications specified in section 2.2.1 on the day of the enrollment will be considered disqualified.

## **8. Tuition fee**

The tuition fee and other fees for the Bachelor of Science Program in Culinary Science and Foodservice Management (International Program) are as follows:

8.1 Entry fee: 15,000 THB for King Mongkut's Institute of Technology Ladkrabang (KMITL), Thailand and 500 CHF for the Business and Hotel Management School (B.H.M.S.), Switzerland (One-time payment upon entry into the program).

8.2 Tuition fee: 180,000 THB per semester

8.3 The tuition fee for studying at B.H.M.S, Switzerland: Reduction of 15% on tuition fees or 5000 CHF of the maximum reduction per academic semester will be granted to each student. The tuition fee is based on the entry year. This fee does **not** cover the travelling
